Biography of Barbara Cook

Born in 1929, Barbara Cook came to Purdue in 1956 as a counselor in the Office of the Dean of Women. She received her BA in Sociology from the University of Arkansas in 1951, a M.A. in Student Personnel Administration from Syracuse University in 1954, a Ph.D. in Counseling and Personnel Services from Purdue University in 1967 as well as an honorary doctorate from Purdue University in 1996. One of her early responsibilities as counselor in the Dean's office involved serving as an advisor to Mortar Board, a senior-student honor society over which she presided for nearly thirty years. Cook also served as director of the Placement Service for Women, assistant and associate Dean of Women, associate Dean of Students, and, from 1980-1987, Dean of Students. She was a lecturer in the School of Education starting in 1970, and a professor of education from 1987-1989. Nationally recognized for her efforts in promoting career opportunities for women, Cook served in several positions within the National Association of Women Deans, Administrators, and Councilors (NAWDAC) including serving as President from 1975 – 1976. She is also the recipient of numerous awards for her work, including the Helen B. Schleman Gold Medallion for Distinguished Contributions to Purdue University, the Dean Beverley Stone Award for Personal Counseling Contributions, and the Distinguished Lifetime Mortar Board Member Award. Since her retirement in 1989, Barbara Cook has been an active member of the Lafayette community and involved with many organizations. including the Salvation Army, Greater Lafayette YWCA, West Lafavette Redevelopment Commission, and the Indiana Governor's Commission for Women. In 2004, a sculpture entitled "When Dreams Dance" was dedicated to Cook and her late colleague and friend, Beverley Stone. It is located in between Schleman and Hovde Halls. Today, the current chapter of the Purdue Mortar Board is named in Cook's honor, who advised the group from 1956-1986.

Materials within the collection

Collection Description

Scope

The Barbara Cook papers (1932 – 2007; 6.2 cubic feet) documents the life and work of Barbara Cook, predominately concerning her work as a student personnel administrator and instructor at Purdue University. Cook's collection of research files and essays on women's issues, especially in regards to education, could be useful for any researcher interested in feminist movements of the 1960s and 1970s. The two "student unrest" binders of Series 8 provide thorough documentation of the various clashes between students and administration during the turbulent years of 1968 – 1969. Researchers interested in the profession of student administration will find much of value in the Barbara Cook papers, including documentation on the Syracuse University Student Dean program she attended in 1952, the Education courses she taught in the 1980s on student administration, and speeches she gave to various student groups in her role as an administrator. Types of materials include: correspondence, speech notes, dissertations, photographs, research files, scrapbooks, artifacts, and ephemera. The Barbara Cook papers are organized into nine series:

Arrangement

1. Personal and Professional Documents, 1932 – 2004 (0.5 cubic feet)

Taken as a whole, this series provides a biographical portrait of Barbara Cook, including curricula vitae, travel documents, newspaper clippings, personal manuscripts, and notes about important university administration issues that she was invested in.

2. Research Files and Essays, 1959 – 1989 (0.5 cubic feet)

These research files contain articles and essays about the counseling and education of women. This series also includes manuscripts of essays Cook wrote about these issues.

3. Correspondence, 1956 – 1996 (0.5 cubic feet)

This series contains mostly personal correspondence to and from Barbara Cook, including letters of recommendation written by Cook. Other official correspondence, including carbon copies of outgoing mail arranged by date (date file), from the Dean of Women/Dean of Students office can be found in the Dean of Women/Dean of Students Office papers.

4. Professional Organizations, 1963 – 2004 (0.6 cubic feet)

This series contains reports, newsletter, clippings, pamphlets, correspondence, and ephemera documenting various professional organizations in which Barbara Cook was active, notably NAWDAC (National Association of Women Deans, Administrators and Counselors) and Mortar Board.

5. Education Courses, 1967 – 1989 (1.0 cubic feet)

This series contains planning material, research information, and student essays from graduate-level education courses taught by Cook.

6. Speech Files, 1960 – 2006 (1.0 cubic feet)

This series is predominantly composed of manuscripts of the many speeches Barbara Cook gave in her role in the Dean of Women/Dean of Student's office at Purdue University. In addition, there are several files of research material that she used when writing her speeches.

7. Books, 1967 – 1993 (0.2 cubic feet)

This series contains books from Barbara Cook's collection that have unique significance, such as inscriptions or marginalia. Other books that were donated with the collection but did not have unique value were de-accessioned. Separation sheets listing these de-accessioned books are included in this series.

8. Student Unrest Binders, 1968 – 1969 (0.5 cubic feet)

This two-volume collection of material, compiled by Barbara Cook, provides extensive documentation of the various student protests and contentious campus issues during the years 1968 – 1969. Included are many clippings from the Purdue *Exponent* and other newspapers, official university memos, student-generated flyers, and Barbara Cook's own analysis of the issues and recommendations from Student Administrator position. This series would be of great use to researchers interested in student unrest during this era.

9. Artifacts, Bound Manuscripts, Diplomas, and Scrapbooks, circa 1950 – 2007 (1.45 cubic feet)

This series consists of a number of plaques and signed memorabilia honoring Barbara Cook, diplomas in diploma cases, bound copies of thesis manuscripts, scrapbooks, and other artifacts.

Additions

While processing the Dean of Women records, the archivist discovered materials that belong in the Barbara Cook papers. This material was added to the collection on July 5, 2013 and is housed in Boxes 15 and 16.
