Biography of Leo Zeff

Leo Zeff was an early and pioneering underground psychotherapist in the San Francisco Bay Area. He was first introduced to LSD in 1961, at the age of forty-nine, while working as a Jungian therapist in Oakland. Recognizing its therapeutic potential, he incorporated it (and ultimately other psychoactive substances) into his therapeutic practice. When LSD became an illegal substance in 1966, Zeff continued his psychedelic psychotherapy practice, after much deliberation, in an underground capacity. He recognized that, when administered properly, these substances demonstrated an unparalleled ability to help patients break through repressed emotional material and achieve spiritual insights and personal growth. In the 1970s, Zeff developed a set of guidelines and protocols in regards to screening patients, dosages, set and setting, and a code-of-conduct for both guides and participants in psychedelic sessions. These guidelines have proven to be enormously beneficial to others who conduct sessions both underground, and more recently, in an aboveground, capacity.

In 1977, Alexander Shulgin introduced Zeff to MDMA, which was still legal at the time. Zeff found this substance so impactful and therapeutically beneficial that he curtailed his plans to retire, and ultimately conducted roughly 4,000 sessions with patients and trained nearly 150 guides.

His work and the practices and techniques derived from it are detailed posthumously in a book of interviews with Myron Stolaroff called "The Secret Chief," published in 1997 with the use of a pseudonym. In 2004 it was released as "The Secret Chief Revealed," and his identity was made known.

Prior to his work as a therapist and psychedelic guide, he served as a lieutenant colonel in the U.S. Army.
